Hosted field trips for public and private preschools and elementary schools to expose children to the farm environment, farm animals and gardens including food sources, organic gardening, recycling, natural resources, healthy eating and ethical treatment of animals. Field trips attended by over 500 students. Hosted Farm Day events providing educational tours and animal interaction to local children and adults, attended by over 400 people including a special day for 30 foster kids. Over 700 horseback riding lessons taught.


