4a (Code:) (Expenses \$ 11,373. including grants of \$) (Revenue \$) RESTORATION OF THE WESTERN FLYER: WE WORKED WITH SHIPWRIGHTS AND CRAFTSPEOPLE IN PORT TOWNSEND, WASHINGTON, TO CONTINUE CAREFULLY RESTORING THE WESTERN FLYER WITH THE GOAL OF PRESERVING ITS HISTORICAL SIGNIFICANCE WHILE EQUIPPING IT WITH STATE-OF-THE-ART TECHNOLOGY. USING SUSTAINABLY SOURCED WOOD, WE REPLACED 90 PERCENT OF THE HULL AND 20 PERCENT OF THE DECKHOUSE. ON JUNE 29, 2022, THE WESTERN FLYER RETURNED TO THE WATER AND WAS TOWED TO SEATTLE, WHERE IT WILL HAVE A HYBRID ENGINE INSTALLED BEFORE RETURNING TO MONTEREY BAY TO BE PUT BACK INTO SERVICE.
