innovative programs address the needs of the entire school community.

The VIP program is geared toward helping offenders become more aware of the impact
that crime has on victims. It is also focused on educating offenders to the long
range harm caused to victims, families and community. The curriculum emphasizes
victims and their rights as a central premise.

VORP is a mediation process which provides interested victims the opportunity to meet
the offender in a safe and structured setting, with the goal of holding the offender

innovative application of the VORP process which focuses directly on the pervasive
crime of juvenile shoplifting.
