THESE ANIMALS ARE TYPICALLY TOO YOUNG, TOO OLD, INJURED, ABUSED, SHY AND OVERLOOKED DOGS AND CATS THAT DO NOT DO WELL IN THE SHELTER ENVIRONMENT. AFRP RESCUED AND FOUND HOMES FOR DOGS, CATS AND RABBITS DURING THE YEAR WITH THE HELP OF OVER 600 VOLUNTEERS. OUR ADOPTION CENTER IN PACIFIC GROVE CONTINUES TO BE A SUCCESSFUL LOCATION FOR FINDING NEW HOMES FOR DOGS AND CATS. IN ADDITION TO OUR MAIN CENTER WE HAVE PARTNERSHIPS WITH PET FOOD EXPRESS, AND PETCO TO HOST SATELLITE CAT ADOPTION CENTERS.
