This past year, we had a change in our treasurer position, with our outgoing treasurer leaving the area (left on a good note but moved far away) and unavailable for us to contact. We now have a new treasurer, but there was some confusion and delay in filing our 990s right at the end of our fiscal year. This is the reason we are filing our 990EZ form now.

Our 2024 990EZ is prepared (using an IRS-approved online tax program) and ready to be filed. Even though our budget is so tiny and we could file the 990N, we rely on local foundation support for grants; these organizations have always asked for a more detailed 990 return.

Since our incorporation more than 30 years ago, Camerata Singers has consistently filed our taxes on time, never late and never had any questions about our return.

This instance occurred solely because of the treasurer change at our critical end-of-the-fiscal-year tax time. We can assure you that we now have a firm timeline in place to ensure changes in our treasurer position will never result in a missed deadline.

Our budget is so low (under \$45,000) penalties will carry a significant impact on our programs. We sincerely ask that our 990EZ be accepted and no penalties assessed.

I am happy to discuss this situation with you further.
