The Elkhorn Slough Foundation's mission is to conserve and restore Elkhorn Slough and its watershed, California's largest tidal salt marsh south of San Francisco Bay. Renowned for its extraordinary biodiversity, Elkhorn Slough features a dynamic working landscape

Land Acquisition- Since 1982, the Elkhorn Slough Foundation (ESF) has led efforts to conserve and restore Elkhorn Slough and its watershed. ESF has protected over four thousand acres of key lands through an active program of acquiring fee and easement interests in properties in the watershed. Public interest conservation values secured by these acquisitions include open space, wildlife and rare species habitat, viewshed protection, groundwater recharge, and water quality improvement. By working in close collaboration with other agencies and organizations, ESF has been able to expand funding and support for Elkhorn Slough protection and conservation management.

4b (Code:) (Expenses \$ 1,551,720. including grants of \$ 0.) (Revenue \$ 0.)

The Tidal Wetland Program (TWP) is a multi-agency effort addressing one of the most critical ecological challenges in the tidal portions of Elkhorn Slough: the dramatic loss of vegetated marshland caused by historic modifications to the slough's hydrology. Collaborating with over 100 scientists, resource managers, local residents, and other stakeholders, TWP has employed an ecosystem-based management approach to halt habitat loss and restore natural functions to the slough system. This effort has resulted in the implementation of more natural tidal flow to the Parson's Slough complex within the Elkhorn Slough National Estuarine Research Reserve, protecting over 450 acres of tidal wetlands.

The Land Stewardship Program oversees the restoration, maintenance, and management of more than 5,900 acres within the Elkhorn Slough watershed. Over the past year, the Stewardship team collaborated with dozens of community volunteers and the California Conservation Corps to carry out a diverse range of conservation efforts. These activities included removing tons of trash and debris, controlling invasive weed species, monitoring key lands and wildlife, mapping natural resources, and propagating native plants. The team collected, germinated, cultivated, and planted thousands of native plants while producing millions of native seeds. Through this work, the program has successfully transformed hundreds of acres of degraded landscapes including eroded sandhills, former eucalyptus groves, and abandoned

Elkhorn Slough Foundation administers these funds for the benefit of ESNERR and slough conservation in concert with the California Department of Fish and Wildlife.

a vibrant social media presence, and various public talks, walks, lectures, and programs designed for school and community groups. Each year, we support over 20 organizations by providing volunteer opportunities for groups such as Boy Scouts, church groups, school groups, corporate volunteer programs, and more. Our outdoor education program engages over 150 local students, helping them build meaningful relationships with their peers and the natural environment. For example, students from Hall Elementary School have the opportunity to regularly experience open spaces through more than 10 visits per school year. We continue to strengthen partnerships with like-minded organizations to conserve the Elkhorn Slough and educate the community about its ecological significance. This includes active participation in Juntxs En La Naturaleza, a collaborative group that includes the Monterey Bay Aquarium, Bird School Project, Latino Outdoors, Puentes Nature, Milpa, Regeneracin, and other organizations. Together, we provide access to nature for over 300 historically underserved families in our community. Additionally, we support the education and volunteer programs at the National Estuarine Research Reserve, which serves 6,000 to 8,000 students annually, as well as the Public Visitor Center, which welcomes 40,000 to 50,000 visitors each year.

The Coastal Training Program (CTP) is an ongoing ESNERR program, funded primarily by NOAA, that partners with other organizations to bring together diverse participants, including farmers, ranchers, private and public land managers, conservationists, regulatory and agency personnel, and scientists, to discuss and explore solutions to key natural resource management issues within the Central Coast region. CTP

also offers a suite of highly sought-after trainings on the biology and management of threatened and endangered wildlife species, such as California tiger salamanders and Western burrowing owls. In FY2023-2024, CTP hosted or co-hosted ten workshops that brought together approximately 500 environmental professionals and community members. CTP builds collaborative networks that develop expertise and leadership to better conserve natural and working lands throughout the Elkhorn Slough watershed, the Central Coast region, and statewide.
