THE FOCUS OF THE TEN-WEEK CURRICULUM IS TO HELP CHILDREN IDENTIFY AND EXPRESS, IN HEALTHY WAYS, THE VARIOUS FEELINGS THEY HAVE. THIS IS ACCOMPLISHED IN SMALL GROUPS AND IN SOME CASES INDIVIDUALLY.
