In FYE 6/30/24, Partnership for Children served 227 children and their families, providing transports to over 3,259 medical appointments via direct rides and gas card provisions. Partnership for Children also provided financial assistance to 133 families, primarily for rent payment assistance. Financial assistance helped families maintain stable housing and avoid homelessness. Financial funeral assistance was provided to eight families upon the death of a child to help ease the financial burden during this most difficult time. Partnership for Children provided a diaper bank and car seat provision service to 111 children, helping to keep children clean, dry, and healthy, as well as safe while riding in a vehicle.
