YOUTH: THE VWA'S YOUTH IN WILDERNESS EDUCATIONAL PROGRAMS ARE DESPERATELY NEEDED BY CENTRAL COAST YOUTH. MONTEREY COUNTY RANKS AMONG THE HIGHEST IN THE NATION IN TEEN VIOLENCE; JUVENILE DELINQUENCY AND GANG VIOLENCE ARE DOMINANT FORCES IN MANY LOCAL COMMUNITIES AND SCHOOLS. YOUNG PEOPLE IN URBAN AREAS OFTEN HAVE MINIMAL RESOURCES OR OPPORTUNITIES FOR A HEALTHY LIFESTYLE.
